

**Terms and Conditions
of the Capital-Amazon-on-box Draw Campaign**

These Terms and Conditions outline the procedures for the promotional campaign titled "Capital-Amazon-on-box Draw Campaign" (hereinafter referred to as the "Capital OBA Draw Campaign" or the "Campaign"), organized by CAPITAL COM MENA SECURITIES TRADING L.L.C, a company incorporated in the United Arab Emirates and having its registered office and place of business at Office 14C, Emirates Towers Office Tower, Trade Center Second, Dubai, UAE, authorised by the UAE Securities & Commodities Authority (the "Authority") to conduct the following financial activities: 1) Trading broker of OTC derivatives and currencies in the spot market; 2) Trading broker in the international markets; and 3) Financial Products dealer (together the "Financial Activities") under First Category (Dealing in Securities) licence number 20200000176 (hereinafter - "Capital.com").

These Terms and Conditions should be read in conjunction with the Capital Terms and Policies as stated above. Any terms not defined within these Terms and Conditions shall have the meaning as defined in the Capital Terms and Policies.

BY PARTICIPATING IN THE CAMPAIGN, THE PARTICIPANTS ACKNOWLEDGE THAT THEY HAVE READ, UNDERSTOOD, AND AGREE TO ABIDE BY THESE TERMS AND CONDITIONS.

1. Campaign Overview

The Capital OBA Draw Campaign is a limited period promotional campaign exclusively provided and sponsored by Capital.com.

For Amazon.ae customers in particular, a person who orders a product from Amazon.ae and receives a Capital.com branded box as part of the Amazon.ae delivery service may scan the QR code on the box and will be taken to a custom landing page built by Amazon.ae where they can find out more info on the Capital-Amazon-on-box Draw Campaign and the relevant links to download the Capital.com app to proceed with the onboarding process. The Campaign is not limited to Amazon.ae's customers only and Amazon.ae has no responsibility for, or control over, the Campaign.

2. Campaign Dates

Capital.com reserves the right to suspend, early terminate or extend the Campaign duration at any time in its sole and absolute discretion without any prior notice to participants.

3. Eligibility

3.1. In order to be eligible for the Campaign, a person shall satisfy all of the following requirements:

Region	Must be domiciled or located in the United Arab Emirates
Individuals	Only individuals (natural persons) are eligible for the Capital OBA Draw Campaign
Age	Must be at least eighteen (18) years old
Eligible Customers	Only new Capital.com Customers who open an account and deposit at least AED 10,000 within the Capital OBA Draw Campaign Dates
Eligible Products	Duly opened account on the CAPITAL.COM Online Trading Platform with the freshly deposited AED 10,000 within the Capital OBA Draw Campaign Dates
KYC (Know Your Customer)	Eligible Customers shall successfully complete the Capital.com standard KYC procedures, including identification, verification and screening procedures to ensure compliance with regulatory requirements. Only those customers who successfully pass the above checks will be eligible to the Capital OBA Draw Campaign.

3.2. Additional Campaign Requirements and Specifications:

3.2.1. A Customer shall not be considered new and will not be eligible for the Campaign, if the details of the Customer already exist in the Capital.com's database as a current or former (including clients with previously closed accounts and/or who has previously registered on the CAPITAL.COM Online Trading Platform).

3.2.2. Each new Customer shall:

- i. Consent to the contents of the Capital Terms and Policies by ticking the corresponding box during the account opening process on the CAPITAL.COM Online Trading Platform;
- ii. Complete client account opening procedures on the CAPITAL.COM Online Trading Platform;
- iii. Access the latest mobile and web application versions of the CAPITAL.COM Online Trading Platform.

3.2.3. A Customer shall deposit an amount of at least AED 10,000 (or equivalent in another currency supported by Capital.com) in a single transaction into their account on the CAPITAL.COM Online Trading Platform.

3.2.4. The deposit shall be made by a Customer via traditional bank transfer or direct bank transfer via Lean.

3.2.5. A Customer may either enter or not enter into trades on the CAPITAL.COM Online Trading Platform using their deposited funds. If the Customer chooses not to enter into trades, the deposited funds need to be present in the Customer's account on the Draw Date. If the deposited funds are withdrawn by the Customer from their account before the Draw Date, such Customer shall be disqualified from participating in the Campaign.

3.2.6. Each Customer participating in the Campaign shall provide their valid phone number and other required details in order to be contacted in case of winning the Prize.

3.2.7. The Campaign is available for either Ordinary or Professional Customers as defined in the Capital Terms and Policies.

3.2.8. The employees of Capital.com or their immediate family members are not eligible to participate in the Campaign.

3.3. Capital.com will determine whether a participant is eligible for the Campaign based on the requirements specified in this Section 3 and may disqualify any participants if there is a ground to suspect that their participation in the Campaign is unfair, deceptive, violating and/or abusive of these Terms and Conditions.

5. Draw Entry

6. Draw Entry Conditions and Total Prize Credit

6.1. Every Eligible Customer who enters the Campaign and satisfies all the requirements of Section 3 hereof within the Campaign Dates will automatically enter into the Prize Draw.

6.2. Multiple entries by one Customer are not allowed (one entry per customer only). An entry into the Campaign gives each Eligible Customer one chance to win the Prize.

6.3. The Prize Draw will be conducted by an independent third party chosen by Capital.com to ensure transparency and fairness of the Draw.

6.4. The Total Prize will be credited to the winner's trading account on the CAPITAL.COM Online Trading Platform within 30 days from the Draw Date (17th Jan 2025) and will be available for immediate withdrawal without any conditions.

6.5. Eligible Customers should remain active and not close their opened account(s) on the CAPITAL.COM Online Trading Platform within the duration of the Capital OBA Draw Campaign and at least 30 days after the Draw Date.

6.6. The winner of the Prize will need to provide a proof of their address and source of funds for AML/CTF purposes to fulfill the crediting of the Prize.

6.7. If any tax is payable on the Prize, this tax will be the winner's liability and will not be incurred by Capital.com. If the law requires Capital.com to withhold this tax and settle with the relevant tax authority on the winner's behalf, then Capital.com shall credit the Prize to the winner's account net of this tax.

7.1.
